

## **MEETING OUTCOME**

The Independent Liquor & Gaming Authority (ILGA) held a board meeting on **Wednesday**, **11 August 2021** to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007*, *Casino Control Act 1992*, *Liquor Act 2007*, *Gaming Machines Act 2001* and the *Registered Clubs Act 1976*. The next ILGA board meeting is scheduled for **Wednesday 15 September 2021**.

## **Definitions:**

**Approved** – The application has been approved. The approval may be subject to conditions or provision of certain information.

**Partially approved** – The application has been partially approved, for example authorising less extensive trading hours or licensed area than what the applicant sought.

**Refused** – The application has been rejected.

**Under consideration** – The matter is yet to be determined. A decision will be published once finalised.

**Determined** – This disciplinary matter or review application has been considered and determined by the ILGA board, with decisions to be published where applicable.

Not considered – The matter was not considered by ILGA at this meeting.

*Withdrawn* – The application has been withdrawn.

*Invalid* – The application has been deemed invalid.
