- If the licence is granted, the remainder fee-on-grant must be paid.
 The fee for this application is available at the gaming machine licence and application fee schedule
- No GST applies.

- This form must be completed by the principal executive officer or an authorised company representative with the relevant company knowledge, who has been duly appointed by the company board/ partners.
- 2. The application is not deemed as completed until all forms are submitted.
