MEETING OUTCOME

The Independent Liquor & Gaming Authority (ILGA) held an extraordinary board meeting on **4 October 2023** to consider applications under the *Gaming and Liquor Administration Act 2007*, *Liquor Act 2007, Gaming Machines Act 2001* and the *Registered Clubs Act 1976*, following the Whitebull appeal decision (20 September 2023) regarding certain gaming machine matters. The next extraordinary ILGA board meeting regarding these matters is scheduled for **12 October 2023**.

ILGA considered the following matters and the status of each matter is listed below.

This document provides a general indication of the status of matters considered, and does not authorise the commencement of licensed trading, or trigger the commencement of any review period. Please refer to the definitions at the end of this document to better understand the status of each matter.

Formal notification will be provided to the applicant separately and, where applicable, a statement of reasons will be provided and published as soon as practicable.
