

# MEETING OUTCOME

The Independent Liquor & Gaming Authority (ILGA) held an extraordinary board meeting on **4 October 2023** to consider applications under the *Gaming and Liquor Administration Act 2007*, *Liquor Act 2007*, *Gaming Machines Act 2001* and the *Registered Clubs Act 1976*, following the Whitebull appeal decision (20 September 2023) regarding certain gaming machine matters. The next extraordinary ILGA board meeting regarding these matters is scheduled for **12 October 2023**.

ILGA considered the following matters and the status of each matter is listed below.

## Definitions:

**Under consideration** – The matter is yet to be determined. A decision will be published once finalised.

**Determined** – This disciplinary matter or review application has been considered and determined by the ILGA board, with decisions to be published where applicable.

***Not considered*** – The matter was not considered by ILGA at this meeting.

***Withdrawn*** – The application has been withdrawn.

***Invalid*** – The application has been deemed invalid.
