

MEETING OUTCOMES

The Independent Liquor & Gaming Authority (ILGA) held a board meeting on **20 March 2024** to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007*, *Liquor Act 2007*, *Gaming Machines Act 2001*, and the *Registered Clubs Act 1976*. The next ILGA board meeting is scheduled for **17 April 2024**.

ILGA considered the following matters, and the status of each matter is listed below.
