What this form is for

It's for the licensee of a hotel, club, packaged liquor (or other premises which function like a bottle shop), or public entertainment venue who seeks approval for minors between the ages of 14-17 to enter and remain in specified parts of the licensed premises.

Generally it allows minors between the ages of 14-17 to work in the licensed premises. It does not allow them to serve, supply or sell alcohol.

Additionally, this form can be used to apply for an exemption to allow minors to enter and remain on the premises of a packaged liquor licence or other premises that function like a bottle shop. It does not allow them to serve, supply and sell alcohol

Note:

If the licensee wishes to have under 18s to serve, supply and sell alcohol you will need to lodge the form AM0180 'Exception from requirement to sell, supply and serve liquor'.
