# Decision of the Independent Liquor & Gaming Authority Application for a packaged liquor licence – Liquorland Parramatta

The Independent Liquor & Gaming Authority considered the application above, and decided on 19 August 2022 to **approve** the application under section 45 of the *Liquor Act* 2007, subject to imposing conditions as set out in Schedule 1.

# Approved manager or individual licensee

The licence cannot be exercised unless and until the Authority or Liquor & Gaming NSW has been notified of the appointment of an approved manager to the licence, or the licence has been transferred to an individual licensee.

In the interest of efficient finalisation of determined matters in a high-volume liquor and gaming jurisdiction, the Authority will only produce a detailed statement of reasons for applications which are refused, partially approved or the subject of stakeholder objections.

### Material considered by the Authority

The Authority has considered the following material in determining the application:

- Application material, including evidence of notification to specified stakeholders and the community about the application;
- Category B community impact statement;
- Premises plan setting out the proposed boundaries of the licensed premises and any applicable authorisations;
- Plan of management for the licensed business at the premises;
- Development consent for the premises;
- Statistics sourced from Liquor & Gaming NSW, Bureau of Crime Statistics and Research, NSW Health and Australian Bureau of Statistics in respect of the socio-economic status, liquor licence density, alcohol-related crimes rates, and health issues in the relevant local and broader communities; and
- Stakeholder submissions in relation to the application, and the applicant's response to those submissions.

# Legislative requirements

The Authority has considered the application in the context of the following sections of the *Liquor Act 2007*, and the associated clauses of the Liquor Regulation 2018:

- Section 3: Statutory objects of the Act and relevant considerations;
- Sections 11A and 12: Standard trading period for liquor licences and a mandatory 6-hour period during which liquor cannot be sold;
- Sections 29-31: Specific provisions in respect of a packaged liquor licence;
- Section 40: Minimum procedural requirements for a liquor licence application to be validly made;
- Section 44: Submissions to Authority in relation to licence applications;

- Section 45: Criteria for granting a liquor licence, and
- Section 48: Requirements in respect of a CIS, including a requirement that the Authority
  must not approve the application unless it is satisfied, having regard to the CIS and other
  available information, that the overall social impact of doing so will not be detrimental to the
  well-being of the local or broader community.

The Authority has also had regard to its Guideline 6 in considering the overall social impact of approving the application pursuant to section 48 of the Act.

### **Key findings**

In accordance with its Guideline 6, the Authority finds that the relevant local community for the purposes of this decision is the suburb of Parramatta, and the broader community is the Local Government Area of Parramatta.

### Positive social impacts

The Authority is satisfied on the material before it that the proposal set out in the application, if approved, would likely benefit the local and broader communities through:

- the provision of increased convenience and choice;
- the licensed premises will adjoin a Coles supermarket that will be located within an
  established mixed use development, and will service nearby residents, shopping patrons
  and nearby businesses, and
- the business owner is a nationally recognised trader operating a large number of retail stores throughout Australia.

# Negative social impacts

The Authority accepts that the proposal may, over time, contribute to an increase in alcohol-related harm in the local and broader communities, including alcohol-fuelled violence, health problems and/or social and amenity issues, having regard to the following:

- there is a high-density crime hotspot in the suburb for incidents of non-domestic assault, malicious damage to property and alcohol-related assault;
- there is a medium-density crime hotspot in the suburb for incidents of domestic assault, and
- the incident rates of alcohol-related non-domestic assault and malicious damage to property are higher in the suburb compared to NSW.

The Authority is nevertheless satisfied that these risk factors are sufficiently mitigated by the following:

- there are no agency or public objections;
- the incident rates of alcohol-related domestic assault and alcohol-related disorderly conduct are lower in both suburb and LGA compared to NSW;
- there are low saturation rates of packaged liquor licences in the LGA compared to NSW;
- there are lower rates of both alcohol-attributable hospitalisations and deaths in the greater community compared to NSW;
- health statistics indicate an above-average level of socio-economic advantage in the suburb. and
- the harm minimisation measures are set out in the plan of management and licence conditions as set out in Schedule 1.

### Overall social impacts and conclusion

Having considered the positive and negative social impacts that are likely to flow from the applicant's proposal, the Authority is satisfied that the overall social impact of approving the application will not be detrimental to the well-being of the local or broader community.

The Authority is also satisfied that the other legislative requirements for the approval of the application have been met.

The Authority finds, having regard to the above, that approving the application is consistent with the statutory objects and considerations of the Act to regulate the liquor industry in line with the community's expectations, needs and aspirations, and facilitate the balanced and responsible development of the liquor industry and related industries.

Accordingly, the Authority approves the application under section 45 of the Act.

# Schedule 1 – Licence conditions to be imposed Liquorland Parramatta

# 1. 6- hour closure period

Section 11A of the *Liquor Act 2007* applies to this licence. Liquor must not be sold by retail on the licensed premises for a continuous period of 6 hours between 2:00 AM and 8:00 AM during each consecutive period of 24 hours. The licensee must comply with this 6-hour closure period along with any other limits specified in the trading hours for this licence.

#### 2. Retail sales

Restricted trading and NYE (std) Retail Sales

Good Friday Not permitted

December 24<sup>th</sup> Normal trading Monday to Saturday 8:00 AM to 12:00 AM midnight Sunday

Christmas Day Not permitted

December 31st Normal trading

# 3. Social impact

The business authorised by this licence must not operate with a greater overall level of social impact on the well-being of the local and broader community than what could reasonably be expected from the information contained in the community impact statement, application and other information submitted in the process of obtaining this licence.

### 4. Liquor Accord

The licensee or its representative must join and be an active participant in the local liquor accord.

### 5. Plan of Management

The premises is to be operated at all times in accordance with the Coles Liquor NSW Management Strategies and House Policy for the Responsible Service of Alcohol documents, as submitted to the Independent Liquor and Gaming Authority ("the Authority") in support of the licence application and as may be varied from time to time after consultation with the Authority. A copy of these documents is to be kept on the premises and made available for inspection on the request of a police officer, council officer, Liquor and Gaming NSW inspector, or any other person authorised by the Authority.

# 6. Closed-circuit television system

- 1) The licensee must maintain a closed-circuit television (CCTV) system on the licensed premises ("the premises") in accordance with the following requirements:
  - (a) the system must record continuously from opening time until one hour after the supermarket/general store is required to close,
  - (b) recordings must be in digital format and at a minimum of ten (10) frames per second,
  - (c) any recorded image must specify the time and date of the recorded image,
  - (d) the system's cameras must cover the following areas:
    - (i) all entry and exit points to the supermarket/general store, and
    - (ii) all publicly accessible areas (other than toilets) within the licensed premises.
- 2) The licensee must also:
  - (a) keep all recordings made by the CCTV system for at least 30 days,

- (b) ensure that the CCTV system is accessible at all times the system is required to operate pursuant to clause 1(a), by at least one person able to access and fully operate the system, including downloading and producing recordings of CCTV footage, and
- (c) provide any recordings made by the system to a police officer or Liquor and Gaming NSW inspector within 24 hours of any request by the police officer or Liquor and Gaming NSW inspector to provide such recordings.

### 7. Crime scene preservation

Immediately after the person in charge of the licensed premises or a staff member becomes aware of any incident person on the premises, the person in charge of the licensed premises and/or staff member must:

- 1. take all practical steps to preserve and keep intact the area where the act of violence occurred,
- retain all material and implements associated with the act of violence in accordance with the crime scene preservation published from time to time on the Liquor and Gaming NSW website
- 3. make direct and personal contact with NSW Police to advise it of the incident,
- 4. and comply with any directions given by NSW Police to preserve or keep intact the area where the violence occurred.
- 5. In this condition, 'staff member' means any person employed by, or acting on behalf of, the licensee of the premises, carry on security activities (e.g. crowd controller or bouncer) on or about the premises.

### 8. Requirement to maintain an incident register

- 1. The licensee must maintain a register, in which the licensee is to record the details of any of the following incidents such incident:
  - a) any incident involving violence or anti-social behaviour occurring on the premises,
  - b) any incident of which the licensee is aware that involves violence or anti-social behaviour occurring in the involves a person who has recently left, or been refused admission to, the premises,
  - c) any incident that results in a person being turned out of the premises under section 77 of the Liquor Act 2007,
  - d) any incident that results in a patron of the premises requiring medical assistance.
- 2. The licensee must, if requested to do so by a police officer or Liquor & Gaming NSW inspector:
  - a) make any such incident register immediately available for inspection by a police officer or Liquor & Gaming
  - b) allow a police officer or Liquor & Gaming NSW inspector to take copies of the register or to remove the register from the premises.
- 3. The licensee must ensure that the information recorded in the incident register under this condition is retained for at least 3 years from when the record was made.

### 9. Public Holiday trading hours

The licensed premises must cease to trade by 8:00 PM, on public holidays.
