



A statutory board established under the Gaming and Liquor Administration Act 2007

The Independent Liquor and Gaming Authority (ILGA) held a board meeting on **Wednesday, 14 March 2018** to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007*, *Casino Control Act 1992*, *Liquor Act 2007*, *Gaming Machines Act 2001* and *Registered Clubs Act 1976*. The next ILGA board meeting is scheduled for **Wednesday, 11 April 2018**.

Definitions:

Under consideration – The matter is yet to be determined by the ILGA board. The decision will be published once finalised.

Determined – This disciplinary matter or review application has been considered and determined by the ILGA board, with decisions to be published where applicable.

Not considered – The matter was not considered by the ILGA board at this meeting.
