

MEETING OUTCOME

The Independent Liquor & Gaming Authority (ILGA) held an extraordinary board meeting on **12 October 2023** to consider applications under the *Gaming and Liquor Administration Act 2007*, *Liquor Act 2007*, *Gaming Machines Act 2001* and the *Registered Clubs Act 1976*, following the Whitebull appeal decision (20 September 2023) regarding certain gaming machine matters as well as additional Liquor & Gaming applications.

ILGA considered the following matters and the status of each matter is listed below.

This document provides a general indication of the status of matters considered, and does not authorise the commencement of licensed trading, or trigger the commencement of any review period. Definitions:

Refused – The application has been rejected.

Under consideration – The matter is yet to be determined. A decision will be published once finalised.

Determined – This disciplinary matter or review application has been considered and determined by the ILGA board, with decisions to be published where applicable.

Not considered – The matter was not considered by ILGA at this meeting.

Withdrawn – The application has been withdrawn.

Invalid – The application has been deemed invalid.
