Clubgrants Scheme

Category 1 Clubgrants: Available Funding by LGA (2021–2024)

Under the Clubgrants Guidelines (Part 6) Clubgrants local committees must be established in every local government area (LGA) where the Clubgrants Category 1 liability of local qualifying clubs exceeds \$30,000 in the gaming machines tax year.

The Guidelines also require applicable clubs to advise the local communities in writing of their Category 1 funding allocations made in the previous tax year.

The following tables show:

- LGAs where the Category 1 Clubgrants tax year funds available required a local committee to be established (i.e. allocation of funds exceeded \$30,000) for 2021, 2022, 2023 and 2024 (see Table 1)
- LGAs where there was not a requirement to establish a Clubgrants local committee (i.e. allocation of funds did not exceed \$30,000) for 2021, 2022, 2023 and 2024 (see Table 2).

This information satisfies clause 6.3.1 (*Mandatory provision of information by clubs*) of the Clubgrants Guidelines and provides the data required to make an estimation for each LGA of the funds available for the next gaming machine tax year and to indicate whether a local committee must be established.

Explanatory notes on data

The rebate amount under the Category 1 Clubgrants scheme shown in Table amounts to 0.75% of the clubs' gaming machine profits over \$1 million.

Clubgrants eligible clubs generally provide funds in excess of the maximum gaming machine taxation rebate, and the figures provided do not include any amounts in excess of the maximum rebate that clubs may choose to provide.

Please note this information is subject to ongoing assurance and could be adjusted at a later date if required.
