A statutory board established under the Gaming and Liquor Administration Act 2007

The Independent Liquor and Gaming Authority (ILGA) held a board meeting on **Wednesday**, **14 June 2017** to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007, Casino Control Act 1992, Liquor Act 2007, Gaming Machines Act 2001 and Registered Clubs Act 1976.* The next ILGA board meeting is scheduled for **Wednesday**, **19 July 2017**.
