Local council's notice of intention to establish a special entertainment precinct

Background

Local councils can establish Special Entertainment Precincts under section 202 of the *Local Government Act 1993*.

These are areas where councils can decide requirements for amplified music and adopt their own plans to encourage more live music and performance.

A Special Entertainment Precinct can be a single premises or a precinct, streetscape, or otherwise defined locality in which—

- a. amplified music that is played is regulated by or under a law other than the *Liquor Act 2007*,
- b. requirements about noise attenuation apply to certain types of development,
- c. participating venues in special entertainment precincts are authorised to trade longer

A council may amend its local environmental plan to establish a Special Entertainment Precinct. If it does so, it needs to have a published plan for regulating noise from amplified music and to notify local residents and persons moving into the area.

What this notice is for

This notice is for local councils to tell Liquor & Gaming NSW about their intention to establish or vary a Special Entertainment Precinct in their local area.

Councils are strongly encouraged to notify Liquor & Gaming NSW in writing before establishing a Special Entertainment Precinct. This is to ensure that there is a smooth transition when plans for the Precinct are implemented and Liquor & Gaming NSW can effectively carry out its regulatory responsibilities.

Once a Precinct is established, requirements on amplified music that would normally apply under the *Liquor Act 2007* will not apply in these precincts, including any amplified music conditions on liquor licences.
