

MEETING OUTCOME

The Independent Liquor & Gaming Authority (ILGA) held an extraordinary board meeting on **27 September 2023** to consider applications under the *Gaming and Liquor Administration Act 2007*, *Liquor Act 2007*, *Gaming Machines Act 2001* and the *Registered Clubs Act 1976*, following the Whitebull appeal decision (20 September 2023) regarding certain gaming machine matters. The next extraordinary ILGA board meeting regarding these matters is scheduled for **04 October 2023**.

ILGA considered the following matters and the status of each matter is listed below.
