A statutory board established under the Gaming and Liquor Administration Act 2007

The Independent Liquor & Gaming Authority (ILGA) held a board meeting on **Wednesday**, **13 November 2019** to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007, Casino Control Act 1992, Liquor Act 2007, Gaming Machines Act 2001* and the *Registered Clubs Act 1976*. The next ILGA board meeting is scheduled for **Wednesday**, **11 December 2019**.

## Definitions:

*Refused* – The application has been rejected.

*Under consideration* – The matter is yet to be determined. A decision will be published once finalised.

**Determined** – This disciplinary matter or review application has been considered and determined by the ILGA board, with decisions to be published where applicable.

*Not considered* – The matter was not considered by ILGA at this meeting.

*Withdrawn* – The application has been withdrawn.

*Invalid* – The application has been deemed invalid.
