EXECUTIVE SUMMARY

- Venue name: Clarendon Tavern
- Venue address: 244 Hawkesbury Valley Way, Clarendon NSW 2756
- Local Government Area ("LGA"): Hawkesbury City Council
- ABS Statistical Area Level 2 ("SA2"): Richmond Clarendon
- Current Gaming Machine Threshold (GMT): 12
- Number of gaming machine entitlements ("GME's") held: 12
- Proposed GMT: 18
- The harm minimisation measures and responsible gambling practices and services offered at the Venue are elaborated on below but a summary of the measures and practices and services at the Venue is as follows:
 - a) Separating the gaming room from the remainder of the Venue;
 - b) Free entry;
 - c) The gaming room is not viewable from a public street;
 - d) CCTV monitoring;
 - e) Monitoring by gaming attendant employees;
 - f) A clock is in the room and is set to the correct time;
 - g) The staff involved in monitoring the gaming room and the licensee all hold a Responsible Conduct of Gaming qualification;
 - h) Brochures and other promotional material is on display warning about the risks of problem gambling and promoting problem gambling counselling services, such as, GameCare (AHA);
 - i) No gaming promotions in the form of gaming inducements are provided.
- Proposed positive contribution:
 - (a) \$398,717.76 to be paid in annual instalments over 5 years into the Responsible Gambling Fund pursuant to section 36A of the Gaming Machines Act 2001 and section 115B of the Casino Control Act 1992.
 - (b) Forfeiture pursuant to section 20(3)(b) of the Act: for each transfer of 6 GME's 2 shall be forfeited to Liquor & Gaming NSW ("LGNSW"). Furthermore, pursuant to section 20(7) if the proposed GMT increase and transfer of GME's are approved the transferor-hotel's GMT will reduce by the number of entitlements purchased, which would include those forfeited. This will result in a reduction in the number of approved gaming machines in New South Wales.

THE VENUE

The Venue's SA2, Richmond – Clarendon (Band 2) has a limit of 341 authorised gaming machines: that total being comprised of 339 gaming machine entitlements ("GME's") and two poker machine permits ("PMP's"). Neighbouring SA2's within 5 kilometres of the Venue are:

- Yarramundi Londonderry: Band 1; limit of 1346 authorised gaming machines; nil GME's and nil PMP's,
- Kurrajong Heights Ebenezer: Band 1; limit of 28 authorised gaming machines; 28 GME's; nil PMP's,
- Pitt Town McGraths Hill: Band 1; limit of 123 authorised gaming machines; 123 GME's; nil PMP's, and
- Windsor Bligh Park: Band 2; limit of 359 authorised gaming machines; 353 GME's; six PMP's.

all of which are located within the Hawkesbury City Council LGA.




Fig 1. Source: http://quickstats.censusdata.abs.gov.au/census_services/getproduct/census/2016/quickstat/124041466?open document

The premises is not a new premises as such clause 38 of the Gaming Machines Regulation 2010 ("the Regulation") does not apply to this application.

The Venue has a total floor space of 1959 square metres. The floor plans are included in this application as "Attachment 1", and show the current licensed boundaries, and also the gaming room where all the current and proposed gaming machines shall be located.

The Venue provides a wide range of facilities including bistro, a full bar service, sports wagering, gaming and a beer garden.

The Venue's current trading hours in the Bistro and saloon bar, TAB, bar services areas, sports bar, gaming room, outdoor dining and beer garden, and verandah adjacent to the outdoor dining and beer garden are:

Monday to Thursday

10:00am to 12:00am

Friday to Saturday

10:00am to 2:00

Sunday

10:00am to 10:00pm

The current trading hours in the remaining areas of the Venue are:

Monday to Saturday

10:00am to 12:00am

Sunday

10:00am to 10:00pm

The gaming machine shutdown period is from 4:00am to 10:00am on Monday to Sunday and on public holidays.

LOCAL COMMUNITY

The local community is the Richmond – Clarendon LSA.

The Australian Bureau of Statistics (ABS) draws its data from the 2016 Censuses and most notably discloses the following in relation to the LSA:

- the total population is 13,842;
- of the total population 47.7% is male, which is less than the state average of 49.3% and the national average of 49.3%;
- of the total population 52.3% is female, which is more than the state average of 50.7% and the national average of 50.7%;
- 41.7% of the population has attained a tertiary qualification of a Bachelor degree level and above, compared to the State average of 23.4% and the national average of 22%;
- Full-time employees made up 60.9% of the total population, compared with the state average of 59.2% and the national average of 57.7%;
- The unemployment rate of 5.8% is lower than the state average of 6.3% and the national average of 6.9%.

A copy of the ABS Quick Stats data is attached as Attachment "2".

The Census of Population and Housing: Socio-Economic Indexes for Areas (SEIFA), Australia, 2016 was also referred to determine the presence of any socio-economic vulnerability in the LSA. The Richmond – Clarendon LSA scored as follows:




Fig. 2. Source: http://stat.data.abs.gov.au/Index.aspx?DataSetCode=SEIFA_SSC#

- Index of Relative Socio-economic Advantage and Disadvantage: 972 (see Fig. 2). ABS notes that a higher score indicates higher advantage and lower disadvantage.¹
- 2. Index of Relative Socio-economic Disadvantage: 987 (see Fig. 3). ABS notes that a higher score indicates lower disadvantage.²




Fig 4. Source: http://stat.data.abs.gov.au/Index.aspx?DataSetCode=SEIFA SSC#

- 3. Index of Economic Resources: 982 (see Fig. 4). ABS notes that a low score indicates a relative lack of access to economic resources.³
- 4. Index of Education and Occupation: 968. ABS notes that a low score indicates relatively lower education and occupation status of people in the area in general.⁴



The fairly high scores show that socio-economic vulnerability is relatively low in the Richmond – Clarendon LSA, while in terms of the factors of economic resources, education and occupation are relatively high in the LSA. The SEIFA data and lower-than-average Aboriginal and Torres Strait Islander population illustrates that the population of the LSA is not highly vulnerable to financial difficulties, and by extension, not highly vulnerable to developing gambling addictions.

OGILVY REPORT ON PREVALENCE OF GAMBLING AND PROBLEM GAMBLING IN NEW SOUTH WALES (2012) ("REPORT")

The Report made numerous findings but of those the most relevant were that:

- the demographic pattern of problem gamblers was more likely to involve men than women (1.4% of men compared with 0.1% of women) and young men (aged 12 24) were the most susceptible (2.4%);
- problem gambling was highest amongst single people (1.2% compared to 0.5% of those who were married or living as married);
- problem gambling was also associated with education level problem gambling being lowest among those with university degrees (0.1%) and highest amongst those who left school before year 10 (2.6%);
- there was also a strong association with employment status, with problem gambling being more than three times higher amongst unemployed people (3.2%) than amongst those in full time work (1.0%). The figure was even lower for part-time workers, students, retirees/pensioners and others.

The ABS data showed that the Richmond – Clarendon LSA had a higher proportion of females than males in the total population. 42.4% of residents in the LSA are in a registered marriage and 10.4% indicated that they were in a de facto marriage. The proportion of those in de facto marriages was higher than the state average of 9.4%

and the national average of 10.4%. The ABS data did not focus on persons who were "single", as such, it is difficult to directly compare the report data with the ABS data and to draw reasonable conclusions as to the likelihood of problem gambling in the LSA in terms of the factor of being single. ABS data did measure people who were "not married" but these included people aged a minimum of 15 years, who lack legal capacity.

The report indicated that education was another factor in the presence of problem gambling. The data showed that 13.1% of residents hold a bachelor degree or higher tertiary qualification which is lower than the state and national averages, however, the percentages of residents who have attained certificates level III or IV or advanced diploma and diploma level qualifications were all higher than the state and national averages. These statistics are based on the entire LSA population, as such, those demographics which should not be taken into consideration, such as current school, university and college students are taken into account, thereby resulting in an artificially reduced representation of persons who have attained tertiary education. The emphasis on the higher attainment of certificates and diplomas corresponds with the above-average proportion of residents who work as technicians and trades workers, labourers and machinery operators and drivers. There are also above-average proportions of residents working as community and personal service workers.

The median weekly household income of \$1,317.00 is slightly below-average but this should be read in the context of the age-related demographics. The respective proportions of persons aged 65-69, 70-74, 75-59, 80-84 and 85 years and over were each higher than the state and national averages. As such, a significant proportion of the overall LSA population are at retirement or semi-retirement age, which would impact on the amount of income produced per household but would not mean that such households are financially vulnerable as retired persons will have savings and perhaps investments. The ABS data does not examine income sources.

HARM MINIMISATION AND RESPONSIBLE GAMBLING MEASURES

The primary purpose of the business carried out at the Venue is the sale of liquor by retail and sports wagering.

The keeping and operation of gaming machines does not detract unduly from the character of the Venue or from the enjoyment of patrons, particularly in light of the Services available.

Gaming machines are provided within a designated gaming room within the Venue. The gaming room is compliant with the Gaming Machines Act and the Regulation as it is:

- located in a bar area of the Venue;
- physically separated from the general bar area by permanent walls with at least the bottom half of such wall being constructed of opaque material;
- situated such that patrons are not compelled to pass through the gaming room in order to enter or leave the Venue or to gain access to another part of the Venue and situated such that gaming machines cannot be seen from any place outside the Venue;
- available to enter free of charge;
- · set up so that machines are suitably spaced;
- there is a doorway or space that provides access to an operating bar and bathroom for each gender without the need for patrons to leave the Venue;
- cannot be viewed from a public street; and
- monitored by CCTV, the Applicant and gaming attendant employees.

Furthermore, the Venue is compliant with the Act and the Regulation in that:

- The Applicant and gaming attendant employees supervise the gaming room enabling them to detect any possible signs of problem gambling in patrons;
- the Applicant and staff involved with gaming hold a current Responsible Conduct of Gambling qualification;
- the Venue provides a self-exclusion scheme to patrons on request. The self-exclusion scheme is offered through GameCare operated by AHA (NSW);
- the name and contact details of a gambling help counselling service is available in the gaming room at all times to patrons and each self-exclusion scheme participant;
- a statement advising patrons that a self-exclusion scheme is available and the name and contact details of GameCare who is able to assist patrons with becoming a participant in the scheme conducted by the Venue is displayed in the gaming room;
- all prescribed signage is displayed including display of information concerning chances of winning, the dangers of gambling and counselling services;
- brochures are displayed, including in community languages, informing patrons
 of the potential dangers of gambling, the availability of counselling and selfexclusion scheme;
- no ATM is located in the gaming room and patrons are not permitted to make withdrawals on credit;
- the Venue does not advise or promote the availability of gaming machines at the Venue or at all;
- clocks are visible to all patrons in the gaming room and set to and accurately reflect the correct time;
- the Venue does not accept third party cheques nor permits the cashing of cheques;

- the Venue limits cash payment of winnings to \$5,000.00;
- minors are not permitted to access the gaming room and for the avoidance of any doubt, prohibited from operating gaming machines;
- prize winning cheques are clearly identified as prize winning cheques;
- complies with the gaming machine shutdown hours endorsed on its licence.
- all gaming machines kept at the Venue are approved gaming machines and are connected to an authorized CMS;
- gaming related signs are not visible from the outside of the Venue and are situated within the Venue;
- no inducements are offered for the use of gaming machines at the Venue.

The Venue currently employs, and will continue to employ if this LIA is approved, the following additional harm minimisation measures that exceed the requirements of the Act and Regulation:

- The Venue maintains an incident log and is maintained daily of any incidents involving staff observing indications of problem gambling in patrons and interventions by staff;
- No waiter service is provided to patrons playing the gaming machines to encourage patrons to take breaks to access beverages and food and which also provides reality check opportunities for gambling patrons.

POSITIVE CONTRIBUTION - S 36(3)(c)(i)

Financial contribution

The primary positive contribution shall be made by way of a financial contribution of \$398,717.76 if this application is approved. The proposed contribution shall be made to the Secretary of the Responsible Gambling Fund pursuant to section 36A of the Gaming Machines Act 2001 and section 115B of the Casino Control Act 1992. The positive contribution was calculated by relying on the gaming performance data report enclosed as "Attachment 3".

Calculation of amount of financial contribution

The amount of the financial contribution was calculated in accordance with the new formula set out in GL4014 Class 1 Local Impact Assessment process guidelines published by the Independent Liquor & Gaming Authority, that is, 15% of the average profit of the existing machines in the Venue, multiplied by the number of proposed additional GME's, and multiplied by the number of years over which the contribution can be paid (i.e. 5 years). The average profits were calculated from 12 months of gaming performance data (see Attachment 3 which provides 13 months of data).

Additional positive contribution

The second positive contribution which this application will have if it is approved is forfeiture of two GME's for every block of 6 GME's pursuant to section 20(3)(b) of the Gaming Machines Act 2001 ("the Act"). Furthermore, pursuant to section 20(7) of the Act if the proposed GMT increase and transfer of GME's are approved the transferor-hotel's GMT will reduce by the number of entitlements purchased, which would include those forfeited. Therefore the operation of sections 20(3)(b) and 20(7) of the Act will result in a reduction in the number of approved gaming machines in New South Wales.

SUBMISSIONS FROM STAKEHOLDERS

The Applicant is unaware of any specific community concerns but in the event any arise following advertising and notification requirements associated with the Application they will be addressed at that time.

CONCLUSION

The Applicant submits that this Class 1 LIA accompanying the 'low range' Application satisfies the requirements of section 36(3) of the GMA, applicable regulations and guidelines for the Authority to approve the application. Approval is sought for this application to enable the business owner to maximise the Venue's commercial potential in light of the owner's recent acquisition of the Venue.

Section 36(3)(a) and (b)

The applicant submits that this LIA complies with the requirements of the Division and the regulations in relation to a class 1 LIA, and further submits that this LIA demonstrates that gambling activities in the Venue are currently conducted responsibly and will continue to be conducted responsibly if this application should be approved.

Section 36(3)(c)(i)

The proposed increase in the gaming machine threshold will provide a positive contribution towards the local community where the venue is situated on the basis of the applicant's proposed financial contribution to be paid in accordance with section 36A of the Act.

Section 36(3)(c)(ii)


The Venue is not a new hotel or new club premises, accordingly, the factor in section 36(3)(c)(ii) is not applicable to this application, despite this, the applicant observes that there is no such school, hospital or place of public worship that is in the immediate vicinity of the Venue.

Section 36(3)(c)(iii)


Regulation 37 of the Regulation sets out pre-application consultation requirements but also provides that the provision is applicable only to a class 2 LIA. As explained in the Introduction (page 3 of this LIA) on the basis that the Venue is situated in a Band 2 SA2 and is seeking a low increase of its GMT, it was determined that a class 1 LIA was appropriate rather than a class 2 LIA. Therefore, we submit that reg. 37 is not applicable to this application.

Regulation 41 of the Regulation provides for post-application consultation requirements. Each of these will be complied with.

Accordingly, the Applicant respectfully submits that as the elements for a LIA Class 1 are met the Application should be approved.
