We feel internet sales permit shoud be included in the Producer & Wholesale licence or extra add on application aplicable to the existing licence.

Unfortunately, we are unable to “upgrade” your existing licence to a packaged licence, especially prior to the payment of the annual liquor licence fee. A brand new licence can take up to 120 days to be granted. This is a whole new application and as such, irrespective of whether there is an existing licence in place for your premises, you need to provide further information. You are correct in that a packaged liquor licence application is needed, however, the application supplied is not quite complete. Accordingly, will have to return it and ask that you re-submit the full application.

- Please supply a copy of the certificate issued by ASIC for the business name that matches the proposed licence name, or an extract from ASIC listing directors.

- Please complete the payment amount (the cost is \$2000).
- Part 2B must be completed in full
- Please supply an Appointment of Manager – notice AM0200
- Police, council and site notices must be completed and attached
- Please supply a plan of the proposed licensed premises with existing and proposed boundaries.
- Part 13 must be signed by the directors of JTB Australia Pty Ltd
- **If the application is for a remote sales licence, a Category A community impact statement must be attached:**
  - The form must be completed and signed by the licensee
- **If the application is for a bottle shop, a Category B community impact statement must be attached:**
  - All sections must be completed.
  - The form must be signed by the applicant as per Part 2 of the application for the liquor licence.
  - The following stakeholders must have been consulted with:
    - Local council
    - Local police
    - Department of Health
    - Department of Community services
    - Roads and Maritime Services
    - Local Aboriginal Land Council
    - The occupiers of neighbouring premises

I have included both CIS applications depending on your circumstances. Please resubmit the application in full. Further, you need to surrender your current licence if and when this application is granted. I have also included this form too.

In fairness to all our customers, applications are processed and assessed in the order they are received. Liquor & Gaming NSW does appreciate the importance to businesses of finalising liquor and gaming licences as soon as possible.
