## Music Festival Roundtable 29 May 2020



### Outcomes and Next Steps

The Music Festival Roundtable provides government agencies, lawmakers, regulators and industry stakeholders the opportunity to strengthen relationships, share information, address members' priorities and tackle emerging issues impacting music festivals in NSW.

It is established by the Minister for Customer Service under the *Music Festivals Act 2019*, with its functions specified in the Act and which include supporting the growth of the music festival industry in NSW and the safety of patrons. Membership of the Roundtable is outlined in the Act and comprises equal distribution of government and industry representatives.

Joint statements about key meeting topics and outcomes are published below:

### **Music Festival Roundtable - 29 May 2020**

- The Music Festival Roundtable was postponed from March 2020 due to the COVID-19 pandemic. The Roundtable noted the profound effect that the pandemic has had on the music festivals sector to date and for the foreseeable future.
- The Roundtable noted the Terms of Reference had been endorsed out of session. It was also noted that the plan for the review of the *Music Festivals Act 2019* had been endorsed by the Co-Chairs out of session, following feedback from Roundtable members.
- The Roundtable noted that the NSW Government response to the Coroner's findings of
  the coronial inquest into the death of six patrons of NSW music festivals was released just
  after the December Roundtable where the Roundtable had resolved to discuss the coronial
  inquest recommendations at the next meeting. It was agreed to consider the findings and
  government response at a future Roundtable meeting.
- The Roundtable discussed the information sources utilised for the identification of music festivals under the *Music Festivals Act 2019*, including the efficacy and use of media reports. It was agreed that the *Music Festivals Act* review would address some of these issues and to consider available information sources further at a future Roundtable meeting.
- The Roundtable discussion focused on how best to support the future of music festivals
  following the significant impacts of the bushfires and COVID-19. The Roundtable network
  will be utilised to assist the industry in developing a plan to ensure the safety of patrons and
  support the music festival sector's recovery.
- The Roundtable noted the discussion at the December 2019 Roundtable where industry members raised concerns about the clarity of regulatory processes. The Roundtable agreed to conduct a mapping exercise of all regulatory touchpoints and intersections for music festivals to consider how processes could be streamlined.
- Mary Harrod from DanceWize NSW was presented to the Roundtable on the work of the NSW Users and AIDS Association (NUAA) and DanceWize NSW, harm reduction organisations that identify strategies to reduce the harms of illicit drug use at festivals.
