# STATEMENT OF REASONS

## Our decision

We approve the application under section 45 of the *Liquor Act 2007* (NSW) (the Act), subject to the surrender of on-premises licence number LIQO660010206.

Overall, we are satisfied that the social impact of approving the application will not be detrimental to the well-being of the local or broader community.

## Our findings

### Procedural and trading hour requirements

We are satisfied that the application is valid and meets the Act's requirements for procedural fairness.

The proposed trading hours and 6-hour closure periods for the premises meet the requirements under sections 11A, 12 and 14 of the Act.

The Community Impact Statement (CIS) meets the relevant requirements.

### 'Fit and proper person'

The applicant is a 'fit and proper person' to operate the business as law enforcement agencies raised no concerns about their integrity.

### Responsible service of alcohol

Procedures for the responsible service of alcohol will be in place at the premises from the start of licensed trading, under the plan of management and the conditions on the licence.

### Development consent requirements

The necessary development consent is in force. City of Newcastle Council approved the development application consent DA 05/0844 and OD2020/1751 for the premises on 10 May 2006 and 29 June 2021.

### Community impact

#### *Local and broader communities*

The relevant 'local community' is the community in the suburb of Carrington, and the relevant 'broader community' comprises the Local Government Area of Newcastle.

#### *Diversity and density of licensed outlets*

L&GNSW Liquor & Gaming LiveData Report for Carrington shows:

- there are 7 authorised liquor licenses, of which 4 are authorised to sell packaged liquor. This includes 1 packaged liquor store, 1 registered club licence and 2 hotel licences.
- saturation of Hotel (General Bar) licences in Carrington (0) is lower compared to the Newcastle LGA (2.6), and lower compared to all of NSW (1.4)
- saturation of late-trading outlets in Carrington (51.8) is higher compared to the Newcastle LGA (48.3), and higher compared to all of NSW (34.7)
- clustering of Hotel (General Bar) licences in Carrington (0) is lower compared to the Newcastle LGA (15), and lower compared to all of NSW (39.8)
- clustering of late-trading outlets in Carrington (2) is lower compared to the Newcastle LGA (19.7), and lower compared to all of NSW (73.1).

#### *Crime data (annual rate per 100,000 residents)*

BOCSAR data shows that, in the year to March 2021:

- the premises was located close to hotspots for incidents of alcohol-related domestic assault and malicious damage to property in areas that are likely to be serviced by the licence.
- alcohol-related domestic assault in the Newcastle LGA was lower compared to all of NSW
- alcohol-related non-domestic assault in the Newcastle LGA was higher compared to all of NSW
- late-night alcohol-related non-domestic assault in the Newcastle LGA was higher compared to all of NSW
- alcohol-related non-domestic serious assault in the Newcastle LGA was higher compared to all of NSW
- alcohol-related offensive conduct in the Newcastle LGA was higher compared to all of NSW
- malicious damage to property in the Newcastle LGA was higher compared to all of NSW.

#### *Alcohol-related health data (per 100,000 residents)*

The most recent HealthStats NSW data available show that:

- between 2017/2018 alcohol-related deaths in the Newcastle LGA were higher compared to the NSW average
- between 2017/2018 -2018/2019 alcohol-related hospitalisations in the Newcastle LGA were lower compared to the NSW average.

#### *ABS Socio-Economic Index for Areas (SEIFA)*

SEIFA data as at 2016 indicates that Carrington was relatively disadvantaged and the Newcastle LGA advantaged in terms of household income and residents in skilled occupations compared to other suburbs and LGAs in NSW.

#### **Business model**

We note that The Young Street Hotel is currently operating as an on-premises restaurant with primary service of alcohol under licence no LIQO660010206 known as 'Carrington Place Restaurant'.

The applicant seeks to change the licence to a Hotel (General Bar) licence to align with the current business model of the premises.

The premises will continue to sell food and operate a full kitchen on the ground floor. However, the applicant considers the business model is better suited to as Hotel (General Bar) licence.

It is noted that the on-premises licence will be surrendered if the application is approved.

#### **Benefits proposed by the applicant**

The applicant proposes that the change of licence follows the natural growth of the business and will allow the premises to market itself as a hotel which includes accommodation and a bar.

#### **Stakeholder submissions**

We considered the submissions from:

- NSW Police Force, dated 29 March 2021, which objects to the application being granted due to the high concentration of licensed restaurants, cafes, hotels and bars in the near vicinity of the premises; and high crime statistics for the Newcastle LGA. Police have requested that the Hotel (General Bar) licence only be issued for the ground floor and that the conditions attached to the on-premises licence are imposed on the new licence, along with the conditions put to the applicant by L&GNSW.
- City of Newcastle Council, dated 17 March 2021, which notes no adverse findings regarding the application.

- Transport for NSW, dated 15 February 2021, which requests the applicant consider a number of initiatives to assist with responsible service of alcohol to customers, especially young drivers who have a zero alcohol limit; and to help reduce road crashes involving drivers and riders impaired by alcohol.
- Twelve members of the public, between 11 March 2021 and 9 April 2021, which object to the application on the following basis:
  - the licence will likely have detrimental effects on the local community as there is already a high saturation of licensed venues in the suburb.
  - granting the licence may exacerbate antisocial and criminal behaviour.
  - local residents have ongoing issues with delivery trucks, lack of parking and noise disturbance.
  - the premises is also located within close proximity to an early education centre.

We also considered the Applicant's submission in response, to these submissions, which notes that:

- Police have relied upon statistics for the Newcastle LGA and suburb of Newcastle
- the trading hours reflect the hours approved under the current liquor licence
- the application does not seek to authorise the use of gaming machines
- changing the existing liquor licence at the venue will not change the current demographic as it will replace the existing on-premises licence
- while a number of conditions are consented to, the applicant would like the heritage listed former pub to operate as a general bar free from the restrictions of the previous restaurant licence
- the premises has its own car park and off-street delivery access; with deliveries made between 8AM to 4PM and no more than 3 deliveries in a 24-hour period.

## Findings of concern

There is a risk that if the licence was granted, liquor sold at the premises will contribute to an increase in alcohol-related crime, health and other social and amenity issues in the local and broader communities, and in other areas of the State.

### *Factors that may reduce this risk*

However we are satisfied that the risk is reduced by:

- the premises not being located in a crime-density hotspot across any category the Authority normally considers
- no gaming facilities on the premises
- no increase in liquor density as the licence will replace the existing on-premises licence already in operation
- the above average socio-economic advantage in the Newcastle LGA
- the harm minimisation measures set out in the plan of management and licence conditions as set out in Schedule 1

- data published by Bureau of Crime Statistics and Research (BOCSAR), NSW Department of Health and Australian Bureau of Statistics (ABS)
- relevant L&GNSW liquor licensing records
- submission from L&GNSW Compliance, dated 7 April 2021
- submission from a member of the public, dated 9 April 2021

- Section 44: Submissions about licence applications
- Section 45: Criteria for granting a liquor licence
- Section 48: Requirements to apply for a Community Impact Statement (CIS), including making sure that it won't harm the local or wider community's well-being
- Section 121: Minors on licensed premises.

We also considered [Guideline 6](#) to assess the likely social impact to the local and broader community if we approved the application.

The Young Street Hotel, Carrington**

1.	<b>6-hour closure</b>	Section 11A of the Liquor Act 2007 applies to this licence. Liquor must not be sold by retail on the licensed premises for a continuous period of 6 hours between <b>4:00 AM and 10:00 AM</b> during each consecutive period of 24 hours. The licensee must comply with this 6-hour closure period along with any other limits specified in the trading hours for this licence.
2.	<b>Restricted trading &amp; NYE (std)</b>	<p>Consumption on premises</p> <p>Good Friday 12:00 noon – 10:00 PM</p> <p>Christmas Day 12:00 noon – 10:00 PM (liquor can only be served with or ancillary to a meal in a dining area)</p> <p>December 31<sup>st</sup> Normal opening time until normal closing time or 2:00 AM on New Year's Day, whichever is the later</p> <p>Note: Trading is also allowed after midnight into the early morning of Good Friday and Christmas Day if authorised by an extended trading authorisation. 4.	<b>Plan of management</b>	The premises is to be operated at all times in accordance with the Plan of Management dated <b>May 2021</b> as may be varied from time to time after consultation with NSW Police. A copy of the Plan of Management is to be kept on the premises, and made available for inspection on the request of a police officer, council officer, Liquor and Gaming NSW inspector, or any other person authorised by the Independent Liquor and Gaming Authority.
5.	<b>Local liquor accord</b>	The licensee or its representative must join and be an active participant in the local liquor accord.
