

MEETING OUTCOME

A statutory board established under the Gaming and Liquor Administration Act 2007

The Independent Liquor & Gaming Authority (ILGA) held a board meeting on **Wednesday**, **17 November 2021** to consider, among other things, applications under the *Gaming and Liquor Administration Act 2007, Casino Control Act 1992, Liquor Act 2007, Gaming Machines Act 2001* and the *Registered Clubs Act 1976.* The next ILGA board meeting is scheduled for **Wednesday 15 December 2021**.
