Council has considered this application and following comments are provided.

In principle Council has no objections to the proposed liquor licence for Liquorland to be situated within Helensburgh Plaza located at 19-21 Walker Street, Helensburgh.

This application has been reviewed with consideration to CPTED principles.

Please refer to considerations below:

#### Number of packaged liquor outlets on this Street

Helensburgh's geographical isolation lends itself to the local businesses providing services predominantly for residents rather than visitors and tourists.

Currently there are three businesses where liquor can be purchased on Walker Street. Two packaged liquor outlets are both approximately 50 metres away (in both directions) from the applicant's address. A Hotel where liquor can also be purchased resides just over 100 metres away.

#### Operating hours

The applicant requests to operate with a closing time of midnight. In considering the operating hours we encourage fairness with regards to the other existing packaged liquor outlets. This is stated without an understanding of what these existing businesses may have initially requested for their operating hours. They currently operate to 7.30pm and 9pm respectively.

Consideration should also be given to the car park area and customer access late at night – refer to comments below.

### Lighting and CCTV

It may be likely that customers will park on the street at night to access Liquorland. However, the car park and internal covered ramp that leads to the store entry poses some community safety risks.

The ramp is enclosed and meanders down to another level to reach the car park at the back and under the premise. The car park is completely isolated from view of the main street.

Lighting and CCTV should be considered in both these areas.

## Community Safety issues (antisocial behaviour/public drinking)

There have been sporadic concerns raised with Council regarding community safety issues occurring in Helensburgh, and specifically Walker Street. At times issues of antisocial behaviour and public drinking have been reported along with a request for CCTV. It is recommended the applicant, or Liquor and Gaming NSW, liaise with the local police to gain an understanding of the level of antisocial behaviour occurring in Helensburgh, Walker Street and the car park area behind Coles.

#### Helensburgh Alcohol Free Zone & RSA

- The applicant should be aware that Walker Street resides within the Helensburgh Alcohol Free Zone.
- We encourage the applicant to use strategies to mitigate the incidence of secondary supply.
- We encourage the applicant to work with both Council and NSW Police to help mitigate ongoing community safety concerns that may arise in Helensburgh.
