- ▲ If the transfer is required because the existing licensee has died, become disabled or been declared bankrupt, use the AM0323 'Liquor licence transfer: death, disability or bankruptcy of existing licensee' form.
- ▲ If you are a registered club needing to transfer your liquor licence where an amalgamation is proposed, use the AM0325 'Liquor licence transfer: club licence' form.
