What this form is for

This application form is for the licensee of a club, hotel, on-premises, producer/wholesaler, or small bar licence who applies for an authorisation allowing extended trading hours for a special occasion on a specified date.

To qualify for this authorisation, the special occasion must be unique or infrequent; be of local, state or national significance; and be for persons independent of the licensee and premises owner/occupier.

What you need to know

The licence will be subject to a compulsory 6-hour closure period on the same day as the special occasion, if this application is approved. This applies to all sale/supply of liquor on the licensed premises – for a hotel, this includes the sale/supply of liquor under a function on other premises authorisation and a residents bar authorisation

Lodge the application at least 28 days before the special occasion date.

Cost

■ The fee for this application is set out in the <u>Liquor Fee Schedule</u>.

This is a processing fee and is **not refundable** if the application is withdrawn or not granted.

No GST applies. Fees are subject to change without notice.
