What this form is for

This application form is for the licensee of an on-premises licence who applies for a take-away sales authorisation to sell liquor by retail on the licensed premises for consumption away from the licensed premises (except on Good Friday and Christmas Day).

Note A take away sales authorisation that applies to an on-premises licence can only be granted if:

- a) the licence is held by or on behalf of a non-proprietary association and the premises promotes tourism or industry in the local area in which the premises are situated, or
- b) the licensed premises are situated in or on a facility that is under the control or management of a public authority.

A public authority includes:

- a statutory body representing the Crown, including a NSW Government agency *Interpretation Act 1987*, section 13A applies
- a Council within the meaning of the Health Practitioner Regulation National Law (NSW), Part 5A.

If you do not meet this criteria, you cannot apply for this authorisation.
