What this form is for

This form is to notify NSW Police of any function that you will be holding at which you will be using your limited licence. Liquor may only be sold or supplied under a limited licence if you have used this form notify the local police at least 14 days prior to the function. You may hold up to 52 functions per year, or another number if the Independent Liquor & Gaming Authority Board (the Authority) considers it appropriate in your case.

You can choose to either notify the local police of all functions for the year using this form or, alternatively, from time to time as the year progresses.

Cost

There is no charge for making this application.

How to lodge this form


You must submit this form to your local police at least 14 days before the earliest function on the form. Find your local police station at police.nsw.gov.au.
