What this form is for

Use this form to apply for an exemption from a special licence condition, for venues located in the Kings Cross Precinct or the Sydney CBD Entertainment Precinct. Exemptions may be granted if:

- ▲ the exemption is unlikely to result in an increase in the level of alcohol-related violence, anti-social behaviour, or other alcohol-related harm in the precinct, and
- ▲ measures other than the specified condition to which the application relates are in place on the premises, and that such measures will be effective in reducing the risk of alcohol-related violence or anti-social behaviour on or about the premises

An exemption, if granted, may apply to the entire venue or a specific part of the venue. Any exemption granted may be subsequently varied or revoked, in writing to the licensee of the venue.

What you need to know

- ▲ This is the form approved under clauses 53P(4) and 53Z1(4) of the Liquor Regulation 2008 and is an official document for the purposes of section 36 of the *Gaming and Liquor Administration Act 2007*. It is an offence to make a false or misleading statement in this document
- ▲ Lodgement of this application does not discharge the responsibility of the licensee to comply with conditions as required by the liquor laws
- ▲ Initial assessment of an exemption application may identify a requirement for further information and Liquor & Gaming NSW may conduct a compliance inspection.

Cost

- ▲ The fee for this application is set out in the [Liquor Fee Schedule](#). This is a processing fee and is **not refundable** if the application is withdrawn or not granted.

There is a 0.4% surcharge if you pay by credit card. No GST applies. Note that fees may change without notice.
