Use this form to notify Liquor & Gaming NSW (L&GNSW) via Data Monitoring Services (DMS) if you wish to temporarily disconnect authorised gaming machines on your premises in accordance with CMS connectivity arrangements. Disconnection cannot be for a period longer than 12 months. If you are intending to disconnect gaming machines for longer than 12 months, while keeping them authorised to be on the premises, you need to contact the DMS help desk to discuss.

Note:

The CMS monitoring fee will continue to be charged as long as the gaming machines are authorised to be on the premises, even while they are not operating.

DMS will process this form and pass on the details to L&GNSW to ensure your club or hotel remains compliant.

If information is missing, we'll need to ask you to supply the required information to support the application. This may delay our response.
