

Gaming machine threshold increase: removal of hotel – with LIA

What this form is for

If a hotel licence is moving to new premises and:

- ▲ you wish to increase its gaming machine threshold (GMT)
- ▲ you fall into one of the categories listed below

you need to lodge this application form and attach either a Class 1 or Class 2 local impact assessment (LIA).

What you need to know

Under section 36 of the *Gaming and Liquor Administration Act 2007* and section 307A of the *Crimes Act 1900* it is an offence to provide false or misleading information in this application.

A Class 1 LIA is required for venues seeking a threshold increase of:

- ▲ up to 30 in a Band 1 SA2
- ▲ up to 20 in a Band 2 SA2

A Class 2 LIA is required for venues seeking a threshold increase of:

- ▲ more than 20 in a Band 2 SA2.

Gaming Machine Entitlement (GME) transfers associated with licence removal applications are exempt from the usual forfeiture requirements if:

- ▲ You are moving your licence and the attached GMEs to a new location within the same SA2
- ▲ You are removing your licence and the attached GMEs within the same LGA to a SA2 of the same or lower Band than your current location.

Note:

You **do not** need to submit an LIA if:

- ▲ You are removing your licence and the attached GMEs/Poker Machine Permits (PMPs) to a new location within the same SA2
- ▲ You are removing your licence and the attached GMEs/PMPs within the same local government area (LGA) to a SA2 of the same or lower band than your current location
- ▲ You are removing your licence and the attached GMEs/PMPs to a SA2 that directly borders your current SA2 and is of the same or lower band.

You may need to complete a different application form. Look for 'gaming licence forms and applications' at liquorandgaming.nsw.gov.au.

Cost

- ▲ With a Class 1 LIA, the fee payable for this application is \$1,650.
 - ▲ With a Class 2 LIA, the fee payable for this application is \$6,000.
