What this form is for

This application form is for two registered clubs entering into a leasing arrangement to transfer one or more gaming machine entitlements (GMEs) and where:

- ▲ the lessee (the registered club where the GME(s) are being transferred to) needs to increase its Gaming Machine Threshold (GMT) and
- a Local Impact Assessment (LIA) is not required.

What you need to know

- ▲ Under section 36 of the Gaming and Liquor Administration Act 2007 and section 307A of the Crimes Act 1900 it is an offence to provide false or misleading information in this application.
- To be eligible to be a lessor club a registered club must have a Gaming Machine Threshold (GMT) 30 or less.
- ▲ An eligible registered club can lease all of its GMEs.
- ▲ A copy of the signed Model Lease must be submitted with this application form.
- ✓ If you are leasing GMEs you must have sufficient GMT for the premises to which the GMEs are being transferred. If you do not have the correct GMT you will need to apply for it, this may or may not require a Local Impact Assessment (LIA).

Note An LIA is not required where the GMT increase application is made at the same time as the lease transfer and the lessee club:

- ▲ is situated in a Band 1 Statistical Area Level 2 (SA2) and the GMT increase (if approved) when added to the total of all other GMT increases approved over the previous 12 months, is 20 or less.
- is located in the same as the club from which the GME/s are leased.
- is located in the same Local Government Area (LGA) from which the GME/s are leased, and the Band where the lessor club is located is the same or higher than the Band where the requesting the GMT increase is located.
- is located in adjoining local statistical areas (whether or not in the same LGA) as the lessor club from which the GME/s are leased, and the SA2 Band of the transferring lessor club is the same or higher than the SA2 Band of the lessor club requesting the GMT increase.
