**ILGA DELEGATED DECISION – APPLICATION FOR
ON PREMISES –VESSEL CLASS**

Fantasea Dreamer

Under delegation issued by the Independent Liquor and Gaming Authority under section 13 of the *Gaming and Liquor Administration Act 2007*, a designated Public Service employee or other Public Service employee of Liquor & Gaming NSW in the Department of Justice, has decided to grant the application for an on premises vessel class removal, application number 1-6371187073.

On 9 November 2017 and after careful consideration of the application and other material, the delegate decided to approve the application, subject to the following conditions:

Conditions imposed:

1. Section 11A of the Liquor Act 2007 applies to this licence. Liquor must not be sold by retail on the licensed premises for a continuous period of 6 hours between 4:00 AM and 10:00 AM during each consecutive period of 24 hours. The licensee must comply with this 6-hour closure period along with any other limits specified in the trading hours for this licence.
2. The licensee is authorised to sell liquor by retail to passengers on board the vessel, for consumption on board the vessel only between the period commencing one hour before the vessel starts any voyage or passage and ending 30 minutes after the voyage or passage is completed.
3. Liquor must not be sold or supplied after midnight in accordance with the standard trading period for the licence on more than 12 occasions within any 12 month period. At least 14



days before each occasion the following persons or bodies must be notified: (a) the local police, (b) the local consent authority, (c) the Secretary.

Note: This condition does not limit or prevent extended trading between midnight and 2am on 1 January each year.

4. The Licensee is to maintain an approved Incident Register with incidents and details of the action taken to be recorded in the Incident Register at all times.
5. The Licensee must notify the NSW Marine Commander or his/her representative of all serious incidents (serious incidents include any injury sustained by a patron that requires medical treatment or any unscheduled dockings to turn out a person who is intoxicated, violent, quarrelsome or disorderly).
6. The following drinks must not be sold or supplied at any time:
 - (a) Any drink (commonly referred to as a shot, shooter, slammer or bomb) that is designed to be consumed rapidly.
 - (b) Doubles (does not apply to genuine cocktails).
 - (c) Ready to Drink (RTD) packaged beverages exceeding 5% Alcohol by Volume
7. The licensee must not host stag/bucks nights, hen's nights, under 18 events.
8. The Licensee must not permit dance party events to be conducted on the premises.

For the purpose of this condition a dance party event means an event, whether a ticketed event or otherwise, which is open to the public and where the primary activity is entertainment provided by live DJ/DJ's and/or live performance/s for the purpose of dancing. The above condition is not intended to include wedding ceremonies/receptions, corporate events and school formals at which DJ entertainment or other live performance/s for the purposes of dancing.

STATEMENT OF REASONS

1. Material before the ILGA delegate

The decision made by the delegate having considered the application and other relevant material:

- (1) Application form lodged 9 October 2017.
- (2) Certificate of Advertising forwarded 27 October 2017.
- (3) Plan of the proposed licensed premises.
- (4) Certificate of survey for the vessel, forwarded 27 October 2017.
- (5) ASIC company report for the proposed licensee, **Riverside Marine NSW Pty Ltd**.
- (6) No Submissions or Objections have been received.
- (7) Email correspondence between the applicant and Liquor and Gaming NSW,



providing additional information and consenting to the imposition of the proposed conditions, dated 27 October 2017.

2. Legislative framework, statutory objects and considerations

In determining the application, the delegate has considered relevant provisions of the Act, including the objects and considerations that are prescribed by section 3, which state:

3 Objects of Act

- (1) The objects of this Act are as follows:
 - (a) to regulate and control the sale, supply and consumption of liquor in a way that is consistent with the expectations, needs and aspirations of the community,
 - (b) to facilitate the balanced development, in the public interest, of the liquor industry, through a flexible and practical regulatory system with minimal formality and technicality,
 - (c) to contribute to the responsible development of related industries such as the live music, entertainment, tourism and hospitality industries.
- (2) In order to secure the objects of this Act, each person who exercises functions under this Act (including a licensee) is required to have due regard to the following:
 - (a) the need to minimise harm associated with misuse and abuse of liquor (including the harm arising from violence and other anti-social behaviour),
 - (b) the need to encourage responsible attitudes and practices towards the promotion, sale, supply, service and consumption of liquor,
 - (c) the need to ensure that the sale, supply and consumption of liquor contributes to, and does not detract from, the amenity of community life.

3. Statutory tests

- (1) In determining an application for a licence, under section 45(3) of the *Liquor Act* 2007, the delegate must also be satisfied that:
 - a. the applicant is a fit and proper person to carry on the business or activity to which the proposed licence relates,
 - b. practices will be in place as soon as the licence is granted that ensure, as far as reasonably practicable, that liquor is sold, supplied or served responsibly on the premises and that all reasonable steps are taken to prevent intoxication on the

premises and that those practices will remain in place, and

- c. if development consent is required under the *Environmental Planning and Assessment Act 1979* (or approval under Part 4 Division 4.1 or Part 5.1 of that Act is required), to use the premises for the purposes of the business or activity to which the proposed licence relates – that development consent or approval is in force.

4. Community impact test

- (1) Under section 48(5) of the *Liquor Act 2007*, the delegate must not grant a licence, authorisation or approval of a kind prescribed by section 48(2) of the Act unless the Authority is satisfied, having regards to the Community Impact Statement, where required, and any other matter the delegate is made aware of during the Application process, that the overall impact of the licence, authorisation or approval in question being granted will not be detrimental to the local or broader community.
- (2) The test applying under section 48(5) relates to delegated decisions in relation to:
 - a. the grant or removal of a small bar licence (where required),
 - b. a packaged liquor licence (limited to telephone/internet sales),
 - c. an application for extended trading hours to permit the sale of liquor after midnight in relation to a small bar (where required), an on premises relating to a restaurant that includes an application for a primary service authorisation, an on premises licence relating to a karaoke bar, a catering service or a vessel, and an application for a producer/wholesaler licence that includes an application for a drink on premises authorisation.
- (3) The Community Impact Statement provides the Authority with information about the views of relevant stakeholders and other aspects of the local community in which the proposed licensed premises is to be located. This includes, for example, the proximity of the licensed premises to hospitals or health facilities, nursing homes, schools and places of worship.
- (4) Local and Broader Community - for the purposes of this decision, the delegate is satisfied that the relevant “Local Community” is the community within the suburb of Rozelle and the “Broader Community”, the Sydney Harbour area, given the fact this the proposed venue is a vessel.

5. Analysis of Submissions and other Materials

- (1) Having reviewed all of the material, I am satisfied that this application for an on premises vessel class, is unlikely to result in any significant increase in alcohol-related harms in the local community.

- (2) Police, the Secretary to Liquor and Gaming NSW have not forwarded any concerns relating to the application.
- (3) No public submissions were received objecting to this on premises application.
- (4) Inner West Council have not forwarded any concerns relating to the application.
- (5) I am satisfied that the applicant has provided consent to imposing the conditions contained in the licence document.
- (6) I am satisfied that the statutory advertising requirements have been met.

6. Overall social impact

(1) Positive benefits

Fantasea Dreamer is to be primarily used for tourism and sightseeing over the month of December 2017 and some of January 2018. This mainly entails back-up services for a regular 540pm transfer of tour bus tourists from Sydney Olympic Park wharf to Darling Harbour and Circular Quay.

(2) Negative impacts

No objections were received prior to granting this application, the nature of the licence sought means that there are unlikely to be any amenity impacts on the local community.

7. Conclusion

- (1) I am satisfied that procedural fairness was afforded to the applicant and interested parties regarding the decision whether or not to grant the application, as all of those required to be notified of the application were provided with the opportunity to make written submissions and all submissions received were considered and helped inform this decision.
- (2) In accordance with section 45(3)(a) of the Act I am satisfied that the proposed licensee is a fit and proper person to carry on the business or activity to which the proposed licence relates.
- (3) Having considered the venue management plan and related material, under section 45(3)(b) of the Act, I am satisfied that practices will be in place at the premises as soon as the licence is granted that ensure, as far as reasonably practicable, that all reasonable steps are taken to prevent intoxication on the premises, and that those practices will remain in place.
- (4) Consistent with section 45(3)(c) of the Act requiring development consent from the local council, I am satisfied that the required development consent or approval is in force.

- (5) In making this decision under delegation from of the Authority, all statutory objects and considerations prescribed by section 3 of the Act were considered and accordingly, I have determined to grant the liquor licence application with conditions.
