1. Executive Summary

- 1.1 The applicant submits a Class 1 Local Impact Assessment in support of an application under the Gaming Machines Act 2001 ("the Act") for a low range increase to the gaming machine threshold increase of 8 machines.
- 1.2 The subject premises are situated at 170 Menangle Road, Menangle Park NSW 2563, and known as Menangle House The Horse and Jockey Inn within the Campbelltown City Council LGA.
- 1.3 The Authority previously approved a Class 1 LIA and Threshold Increase Application in 2011, in respect of the premises. The applicant complied with the conditions imposed as a consequence of that approval but was unable to acquire sufficient gaming machine entitlements to exploit the quota fulfilment order as prior to the reduction of the threshold.
- 1.4 The Hotel has acquired only 2 entitlements of the quota fulfilment order of 10 authorised pursuant to the 2011 approval. The Hotel was unable to acquire the further 8 entitlements before the threshold was reduced.
- 1.5 The Hotel has complied will all imposed liquor licence conditions, which required the Hotel to make financial contributions to charitable organisations such as St Vincent De Paul Society and Mission Australia.
- 1.6 A threshold increase of 8 gaming machines would bring the overall total to 10, the same amount of gaming machines approved under the previous threshold increase in 2011.

2. Hotel Background

- 2.1 The current Hotel was an old Inn – Menangle House, built in 1834. The current Hotel continues to comprise the historical old inn and has a pictorial museum in addition to the new and modern Horse and Jockey Tavern.
- 2.2 The primary purpose of the Hotel is for the sale of liquor by retail. The keeping and operation of gaming machines at the hotel will not detract unduly from the character of the hotel or from the enjoyment of persons using the hotel otherwise than for the purposes of gambling.
- 2.3 The Hotel provides numerous facilities to their patrons, including the Tabers Al a Carte Restaurant, the Slab Hut Can & bottle bar, TAB and Keno facilities, accommodation, three courtyards and three feature fountains which are sprawled over four acres of luscious lawns for all patrons to enjoy.
- 2.4 The Hotel trading hours are as follows:
Monday to Thursday - 10:00am to 10:00pm
Friday and Saturday - 10:00am to 12:00 midnight
Sunday and Public Holidays - and 10:00am to 10:00pm

- 2.5 The Hotel operators have operated at the premises for over 9 years.
- 2.6 There are no schools, places of worship or hospitals within the immediate vicinity of the Hotel.
- 2.7 The nearest school to the Hotel is Broughton Anglican College, located at 18-83 Menangle Road, Menangle Park. The school is approximately 2.8 kilometres away.
- 2.8 The nearest church to the Hotel is more than 3 kilometres away and the closest hospital is Campbelltown Public Hospital, located approximately 9 kilometres away.
- 2.9 Attachment "A" depicts the area surrounding the premises.
- 2.10 The total internal floor space of the premises is 496 m². A copy of the plan of the premises is attachment "B".

3. Benefit to Local Community

- 3.1 The Hotel is a family oriented venue with a heritage featured bar and dining facilities.
- 3.2 Menangle House is one of the oldest significant heritage buildings in the Menangle Park area. Our clients' purchased Menangle House and proceeded to restore the original buildings and include buildings to the site. The initial costs for restoration of the buildings was approximately \$365,000. In addition to restoration of the buildings a further \$125,000 was paid to install new roads, paths and landscaping for the site.
- 3.3 There continues to be an ongoing cost to maintain and preserve the national significance and importance of the heritage buildings for the use of Hotel patrons and the local community. These costs are at present approximately \$28,000 per annum. To continue to maintain and improve the grounds properly, which include 1.5 acres of open space lawns, a full time maintenance/gardener is required to carry out the maintenance which the applicant is currently not in a financial position to be able to provide.
- 3.4 Over the next five years the ongoing restoration, preservation and conservation of the heritage buildings will require an additional expense costing in the vicinity of \$125,000 or more.

Proposed Scope of Work for Menangle House Horse & Jockey Inn 2014-2019

- Repointing of weathered brick work.
- Water damage protection.
- Roof restoration.

- Preservation of internal joinery.
 - Conservation of ceilings, plaster cornice and ceiling roses.
 - White ant/termite protection.
 - Care and repair of glass windows and features.
 - Maintenance of external timber columns and features.
- 3.5 All of the funds for the restoration of the buildings and the ongoing costs to maintain the building to the standard required for heritage buildings are provided by the owners Greg and Bronwyn Nixon. No funds are received through any government subsidy or grants.
- 3.6 Since the Hotel began operation, it has provided the local community with a first class facility that is used to get together with family and friends to have a drink and a meal, functions such as birthday parties, weddings, corporate & charitable events. Also for the community we offer over venue as a meeting place to discuss matters which affect the Menangle Park area as there are no community halls or facilities available. We continue to support local sporting groups with events and fundraisers.
- 3.7 The Hotel is a supporter of local producers with the purchase of food and produce sourced from the local area.
- 3.8 The Hotel currently employs 11 casual and 7 full time staff. The majority of the staff reside in the local or nearby community.
- 3.9 The Hotel also engages local youths in apprenticeships within the hospitality industry and employs local tradesmen for the ongoing maintenance of the property.
- 3.10 Over the past ten (10) years the Hotel has supported, donated to or provided sponsorship to a large number of local sporting and community organisations as well as various charitable organisations. These include –
- Douglas Park Primary School;
 - Broughton Anglican College, Menangle Park;
 - St Gregor's College, Campbelltown;
 - Kentlyn Public School;
 - Douglas Park Volunteer Bush Fire Brigade;
 - Menangle Park Bush Fire Brigade;
 - Macarthur Sunrise Rotary;

- National Breast Cancer Foundation;
- Childrens' Medical Research at Westmead Hospital;
- The Oaks Football Club;
- Wests Junior Rugby League Football Club; and
- Local families that have suffered tragedy.

- 3.11 The Hotel is also a regular attraction for groups on bus tours of heritage properties within the outer south and western areas of Sydney.
- 3.12 The Hotel offers free Heritage tours of Menangle House complimented with meal discounts to all pensioner, community and special need groups. The tours have increased in frequency over the last year and are occurring on a regular basis.

4. Responsible Gaming Measures

- 4.1 The Hotel management and staff are supportive of and encourage responsible gaming practices and all staff engaged in the operation of gaming machines have completed the prescribed Responsible Gambling Course. A responsible

- gambling certificate for all staff is maintained in a register at the Hotel or staff will have their competency card.
- 4.2 The Hotel is a current member of the Australian Hotels Association (AHA) New South Wales and supports its practices and procedures for gaming harm minimisation.
- 4.3 The Hotel is a current member of the Campbelltown Liquor accord and attends meeting regularly and support there initiatives.
- 4.4 The Hotel has adopted the AHA's Conduct of Gambling Policy since gaming machines were installed at the Hotel.
- 4.5 The Hotel adopted the AHA's self exclusion scheme. All management and staff will be made aware of the program and patrons will be made aware of the program through the required notices.
- 4.6 All staff employed by the Hotel have completed the Responsible Conduct of Gambling Course. A copy of which will be maintained within the prescribed register when applicable, unless the staff member has obtained their competency card. Attached is a copy of the current licensee's certificate of completion of a Responsible Gambling Course.
- 4.7 Patrons of the hotel are made aware of the AHA's counselling services and of the government funded G-Line telephone counselling service.
- 4.8 Patrons are made aware of the chances of winning and the problems associated with excessive gambling through the prescribed signage required to be located on each gaming machine and by way of the prescribed information notices on display.
- 4.9 An ATM is located in the Public Bar area of the Hotel and displays the appropriate signage to notify patrons of the problems associated with gambling.
- 4.10 The Hotel has a policy of not cashing cheques.
- 4.11 The Hotel will comply will advertising requirements in respect of gaming:
- the Hotel will not use the word "casino" in any description or promotion of the Hotel;
 - the Hotel will not permit gaming related advertising material to be displayed on the exterior or interior of the premises;
 - the Hotel will not promote irresponsible gaming or gaming practices;
 - the Hotel will display a clock, that is set to, or within 10 minutes of, the correct time and is in view of patrons in the gaming room;
 - the Hotel will not publish the details of any person who has won a prize in excess of \$1,000; and

- the Hotel will display the prescribed signage with the gaming room, on all gaming machines, on the ATM any EFTPOS facilities.
- 4.12 The hotel currently has 2 gaming machines, located adjacent to the bar area within the Hotel. All gaming Machines are located within a gaming room as prescribed by Clause 9 of the Gaming Machines Regulation 2002, in that:
- a) The gaming room is located in a bar area of the hotel;
 - b) The gaming room is physically separated from the general bar area by walls and doors;
 - c) Patrons are not compelled to pass through the gaming room in order to enter or leave the hotel or in order to gain access to another part of the hotel;
 - d) Entry to the gaming room is free of charge;
 - e) The gaming machines cannot be seen from any place outside the hotel that is used by the public or to which the public has access;
 - f) All gaming machines are suitable spaced in order to facilitate access;
 - g) The gaming room is supervised at all times by way of electronic means and physical present of the licensee or an employee;
 - h) The gaming room has two (2) doorways that provide reasonable access to and from the gaming room to at least one operating bar and at least one toilet for each gender without the need for patrons to go on the a public street, or to any area not forming part of the hotel when moving from the gaming room to the other facilities; and
 - i) The gaming room cannot be accessed directly from a public street.
- 4.13 The Hotel is closed during the mandatory shutdown period of 4.00am to 10.00am Monday to Sunday.

5. Positive Contributions

- 5.1 The applicant has complied with all imposed liquor licence conditions in relation to the previous Threshold Increase approval, which required the applicant to make financial contributions to charitable organisations such as St Vincent De Paul Society and Mission Australia.
- 5.2 Financial contributions in the sum of \$50,000 already made to such charitable organisations have directly enabled the continued delivery of such services provided by St. Vincent De Paul and Mission Australia, which undoubtedly provide a positive contribution to the local community. Please see attached letters confirming contributions (Attachment 3).
- 5.3 The applicant has established an ongoing charitable partnership with St Vincent's Maryfields Day Recovery Centre to hold an annual fund raising event

and guarantee a minimum of \$5,000.00 be raised and provided to the charity each year. Should the application be approved, the annual fund raising events will commence in 2014. The 2014 Family Fun Day fundraiser charity day is proposed to take place on 22 June 2014. Please see attached preliminary Family Fun Day function.

- 5.4 To gain the increase of 8 gaming machines, the hotel is required to purchase 12 gaming entitlements and relinquish 4 entitlements to the NSW State Government. This will lead to an overall decrease state wide of 4 gaming machines.


6. Negative Effect

- 6.1 The proposed Threshold Increase will not cause a negative impact as the Hotel intends to increase the gaming machines to provide the same amount as approved in 2011. Therefore, on the basis of the previous approval, the increase will not cause a negative effect, as it was previously determined a threshold increase of 10 gaming machines would not contribute negatively to the community, rather it would provide positive contributions to the community.
- 6.2 The financial contributions in the sum of \$50,000.00 already made to charitable organisation outweighs the negative impacts that may arise if the new Threshold Increase Application is approved. On the basis of these previous donations and continued financial support within the community, our client seeks the application be approved without any further licence conditions, in order to allow our client acquire the same amount of gaming machines for which a positive contribution has already been provided.

7. Conclusion

- 7.1 It is submitted that the foregoing information complies with the guidelines for a Class 1 Local Impact Assessment attaching to an application for an increase in the gaming machine threshold of the Hotel by addressing the responsible gambling and harm minimisation measures taken by the hotel; identifies the local community of the hotel; and provides information to show that a positive contribution will be made to the local community if the LIA and increase applications are approved.
- 7.2 The approval of the threshold increase by 8 to 10 will enable the licensee the opportunity to potentially recover previous investment in maintaining the heritage building and also assist with future maintenance, which provides a positive impact on the amenity of the area and a source of interest and attraction to the local community which has potential positive economic impacts for the local area. It will also directly benefit local community organisations as the hotel proposes to provide \$5,000.00 a year as part of its partnership with St Vincent's Maryfields Day Recovery Centre to hold an annual fund raising event in order to help St Vincent's Maryfields Day Recovery Centre provide services for people suffering drug and alcohol programs.

- 7.3 The increase may also assist with the retention of local employees and the opportunity for additional staff to be employed for gaming related duties.
- 7.4 Approval would allow our client acquire the same amount of gaming machines previously approved. Therefore, any potential negative impacts have already been assessed as not preventing an increase to the threshold, and the approval will result in positive impacts by way of financial support and contributions to charitable organisations servicing the local community.
- 7.5 Based on the foregoing information and as the Hotel is located within a Band 2 Local Government Area and the application is for a low range increase in the gaming machine threshold, we submit that there are more positive impacts for the community if the threshold application is approved than any negative impact by the installation of an additional 8 gaming machines within the local government area. In addition, the installation of 8 gaming machines at the Hotel will also reduce the overall number of gaming machines state-wide due the forfeiture provisions.
