I'm an international touring musician and music producer who grew up in Sydney. I'm 37 years old and bring in AUD370k, after taxes, a year. Prior to 2011 I was based in Europe from 2006-2010.

Sydney's nightlife is dead. It's that simple. People rush in to get to venues before 01:30 to stay until 03:00. Do you truly know how ridiculous that is? Do you even understand that some peoples' nights start at midnight? Or even later? People that do shift work? People that finish at 18:00 of a Friday? Is this for real?

Let's use an example scenario: An accountant living in Liverpool who works in the CBD and finishes at 18:00 of a Friday.

18:00: Finishes work.

18:20-18:40: Get's on the 18:39 train to Liverpool because the train beforehand only goes to Lidcombe.

19:56: Arrives at Liverpool

19:57: Gets on bus/walks home. Let's be generous and say it only takes 10 minutes.

20:07: Arrives home.
