We were sitting outside having a lovely time, discussing what a great vibe it was to have a street like this, very south of France, when at 10pm our waitress asks us to move inside, as it's the law. (This time a council one). It's Saturday night for goodness sake. Within minutes, the vibe is gone, the street looked deserted, now more like south of Syria. TEN PM ON A SATURDAY NIGHT in the Cross. Another ridiculously stupid law on top of all the others, made by people who think we should all be tucked up in bed by then and certainly can't be responsible for buying a bottle of wine after that time. Or a shot after midnight. Or more than two drinks at a time. It's not just the puritanical lockout laws, it's all these controlling little laws that treat us like children.

If you want to stop the VIOLENCE then treat the source. Why are these young men so violent?? It's happening all the time else where, no matter how many ridiculous nanny laws are put in place.

Many cosmopolitan cities have access to alcohol 24/7, yet they don't have these problems. Why do we? Treat the real problem and let us be responsible for our own drinking behavior, as proper grown ups.
