
Re: lock out laws review



> When I first moved into the area it was lively but there was always a level of respect between those who lived and those who visited the area. Over the last few years prior to the lockout I saw this respect diminish greatly. It became the norm for visitors to the area behave in a way that in any other city wouldn't be tolerated. It seemed there was an attitude of "let's go to the Cross and do and behave however we please" Behaviours such as vomiting and urinating in the street and in doorways was a common occurrence. When coming home after a dinner out I was often subjected to being verbally yelled at when I asked if I could get past to gain access to my unit by intoxicated groups of people slumped in my door way. It is in no way pleasant to have to walk past a group of young men urinating in your street. It seemed at the time the solution was to install portable urinals which were often not used and I felt sent a message that you can do as you like but just make sure you have some level of decency and stop urinating on residents doorsteps.

I speak not only for myself but also other friends who live in the area when I say at times it didn't feel safe when coming home at night any time after 9pm. I witnessed a number of fights and violence towards and between men and women. The bad behaviour wasn't only directed towards people it was also the senseless damage to others property. On more than one occasion a number of the cars particularly those parked in Kellett Way had their side mirrors kicked in, street signs destroyed and common areas vandalised. Garbage was left all over the ground. There was no concept that this was people's neighbourhood and shouldn't be treated like a garbage tip.

> It wasn't just at night there was a feeling of unsafety or having to deal with abusive or unwanted attention. Going to the gym on a Friday morning for a 6am gym class it wasn't uncommon for one of the bars to be full of intoxicated people and for me to be yelled at. In my opinion the area was always going to change due to it close proximity to the city. Surely the increase of residential premises comes with it a responsibility to provide a safe and secure environment? In addition to this it could be argued that people can't be expected to pay high real estate prices and be subjected to such poor behaviour.
